## Participant Assumption of Risk, Release, and Agreement

In consideration of the services of Lake Logan Episcopal Center, their agents, owners, officers, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to LLEC), I hereby agree to release, indemnify, and discharge LLEC, on behalf of myself, my children, my parents, my heirs assigns, personal representative and estate as follows:

1. I acknowledge that my participation in ropes course activities entail known and unanticipated risks, which could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity.

LLEC ropes course programs are based in the "challenge by choice" principal. At any timer you and/or your group are free to withdraw from participation in ropes course activities. The risks include among other things, the potential for: slips, falls, and falling; rope burns; pinches; scrapes; twists, and jolts that could result in scratches, bruises, sprains, lacerations, fractures, concussions, or even more severe life threatening hazards. During any activity there may be contact with plants, animals or insects that could create hazards such as stings, allergies, and or associated diseases.

2. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks.

3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless LLEC from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of LLEC equipment or facilities, including any such claims which allege negligent acts or omissions of LLEC.

4. Should LLEC or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.

5. I certify that I have adequate insurance to cover any injury or damage I may cause to suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I am willing to assume the risk of any medical or physical condition I may have.

6. In the event that I file a lawsuit against LLEC, I agree to do so solely in the state of North Carolina, and I further agree that the substantive law of that state shall apply in that action without regard to the conflict of the law rules of that state. I agree that if any portion of this agreement is found to be void or unenforceable the remaining portions shall remain in full force and effect.

By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against LLEC on the basis of any claim form which I have released them herein.

I have had sufficient opportunity to read this entire document. I have read and understood it, and I agree to be bound by its terms.
